

The highest proportion fall into age band Under 15 with a count of 1,476 representing 25.59 % of the study area. The smallest proportion is in age band 15-19 with a count of 353 which represents 6.12 %. In the study area the most over represented age band in comparison to the base selection is Under 15 with an index value of 143. The band that is most under represented is 55-64 with an index of 82, where an index* of 100 represents the national average.






Within your area social grade DE forms the largest proportion with 1,010 people falling into this group, which is 57.62 % of the overall distribution. The smallest proportion falls into grade AB with a count of 52 taking up 2.96 %. When comparing this to the selected base the most over represented grade is DE with an index* count of 222, whereas the most under represented group is AB with an index count of 13.

Economic activity within the study area shows that 48.36 % of the population are employed, this is 1,814 people, compare this to your base where 54.06 % are employed. The smallest economically active group is Self employed with employees representing 0.45 %, compare this to the selected base where this group represents 2.30 %. When analysing index* values the most over represented group is Unemployed with an index of 388, taking up 8.17 %.


When considering economic inactivity the largest proportion in the study area belongs to the Retired group with a count of 440 representing 11.72 %. The smallest inactive group is Other with 153 which is 4.07 %. When looking at the index values the group that is most over represented is Looking after home/ family with an index of 163, representing 8.89 %.



The smallest number of households live in a Detached dwelling, this is 1 households and makes up 0.04 %. When analysing the index* figures, we can deduce that the most over represented dwelling type is Terraced with a figure of 301, this makes up 79.21 % in the study area.


When considering the tenure of households we can see that the largest proportion are Social rented with a figure of 1,051 making up 45.34 %. The smallest amount fall into the Private rented at 14.47 %. 1,643 households within your area have an income of £19,999 or less, this forms 70.89 % of the overall distribution. The smallest count is 0 and these fall into household income band £50,000 to £59,999 making up 0.00 %. When using your base as a comparison, most households fall into the income band £20,000 to £29,999 which makes up 18.53 % of the overall view. When using index* figures as a guide we can see that the income band £15,000 to £19,999 is over represented making up 25.63 % with an index of 286, the most under represented banding is £50,000 to £59,999 with a figure of 0 making up 0.00 % of the distribution.


